TACL is a state-wide initiative that brings together leaders across sectors in healthcare, business, government, community, advocacy, philanthropy and other sectors to work toward the common goal of improving cancer outcomes in Louisiana.

Mission

TACL is Louisiana's united force to reduce cancer mortality by eliminating racial disparities and health inequities.

Vision

To support initiatives that give communities all across Louisiana access to cancer screening and the ability for each cancer patient to pursue their best treatment options.

A message from our Board Chair

Looking back at 2022 it is sometimes easy to forget that this is the first full year that our efforts have been unimpeded by Covid. It is gratifying to see the progress made during this eventful year and to think of the lives saved by the initiatives put in place because of efforts initiated by TACL and the institutions represented on our executive board. TACL organizations increased colorectal cancer screening rates by over 6%, we piloted a transportation program to assist patients without access.

We secured our first grant for \$75,000 to facilitate increased colorectal cancer screening rates in primary care practices and, lastly, we worked through the Louisiana Health Information Exchange (LaHIE) of the Louisiana Health Care Quality Forum (LHCQF) to develop and approve a cancer screening registry pilot.. TACL has made great strides in the past several years and I am proud to end my run as Board Chair knowing that we have accomplished so much.



Key Challenges

Recovering from Hurricane Ida and Pandemic made it difficult on the healthcare sector. Staff burnout and staff shortages created some barriers for our partners to priortize preventative care, but they overcame those barriers.





2022 IN REVEIW

BRC Initiatives :

- Increasing adherence to treatment standard of care for Breast Cancer
- Identifying individuals who are at high risk for Breast Cancer
- Using Community Health Workers to improve Breast Cancer Patient Outcomes

CRC Initiatives:

- Adopting best practices to increase screening among board organizations and PCPs.
- Increasing Molecular Testing in Colorectal Cancer Patients adopted as a priority
- Increasing Access to Colonoscopies

Partnerships

- Working with Health Plans to identify policy/payment changes that reduce barriers for breast and colorectal cancer screening through the Louisiana Payer Council
- Providing continuing education to CHWS to help them educate and better navigate individuals to breast and crc screening.





MCO Pilot

Launched Managed Care Organizations CHW Pilot in LDH Region 3. Through our partnership with the Louisiana Managed Medicaid Association (LMMA), we have facilitated the training of 5 CHWs to work in Region 3 with a special focus on cancer screenings. These CHWs are shared among all of the MCOs with the help of Volunteers of America.

Coverage of Cologaurd

Through coordinated efforts of our partners, we saw Medicaid Extend Screening Coverage to Cologuard (FIT DNA) this year. Medicaid now covers all approved screening modalities for CRC. We also facilitated distribution of 100 free Cologaurd kits to those in need.

Implemented 90% of Clinical Recommendations

We are happy to report that 90% of the clinical recommendations first set in 2018 for TACL's Organizations have been initiated.

LA 211 Ride United Transportation Access Program



TACL Outcome Highlights (as of April 2023)

- Total Rides: 520
- 2 Individual Riders: 29
- 3 Avg. Rides per Patient: 18
- 4 Avg. Cost per Ride: \$24.59
- 5 Avg. Cost per Patient: \$441

Goal: Provide rides that remove urgent transportation barriers and help meet healthrelated needs for low-income, uninsured or underinsured, and/or at-risk individuals and families. (Medicaid/Medicare also included to address gaps in coverage).

211 Transportation Pilot

Made possible through funding provided by United, TACL launched a pilot at the end of 2022 to help provide transportation to cancer patients for all of their healthcare needs, not just directly related to their cancer treatments.







2022 DATA HIGHLIGHTS

Highest Organizational Participation Ever

Collected annual screening data from 90% of Board Organizations (Health Systems & Payers combined.

Addition of Molecular Testing

Collecting rate of Molecular Testing in Colorectal Cancer Patients added to our annual data collection and named a priority metric for our board organizations.

Improvements in Screening and Narrowing of Racial Disparities



THE YEAR AHEAD: MILESTONES FOR 2023

- \$75,000 Grant from Exact Sciences awarded to continue our PCP Learning Collaborative Initiative:
 - Recruiting a new cohort of Primary Care Practices in the summer of 2023
 - Launching the new collaborative for this program's second year of improving CRC screening in PCPs.
- Cancer Screening Registry: Approved in 2022, moving forward in 2023!
 - Funding secured from the Louisiana Cancer Research Center.
 - Using CRC as the first screening to register among Medicaid patients, we will being to pilot and build the full registry.
- Focus on Late Stage Diagnosis
 - Late stage diagnosis of CRC will be a feature target of 2023; using data on payer type, location, and other demographics of those diagnoses late, we will situate the most impactful efforts to those most in need.
